INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

The semi-annual reports generated by the IACUC and sent to the Institutional Official (IO) do not contain all of the required information. Report sent in October 2016 has not been signed by any of the IACUC members. Findings from the program review are mentioned, but significant from minor deficiencies are not distinguished. An IO report for the March 2017 facility inspection and program review has not been generated. Without clear and concise communication between the IACUC and the IO in the form of semi-annual reports, animal use and facility findings may go unnoticed and/or uncorrected resulting in decreased animal welfare. The IACUC must compile and submit reports to the IO at least once every six months that contain all of the required information.

The animal use protocol identifies painful procedures conducted on the animals. No alternatives to these procedures have been included in the IACUC approved protocol. Animals may undergo unnecessary pain and distress if viable alternatives exist. The principle investigator must consider alternatives to procedures that may cause more than momentary or slight pain or distress. A written narrative description of the methods and sources used (i.e. key words, databases used and date search conducted) must be included in the IACUC approved protocol.
